V. ESG from HUD via Illinois DHS

The following was emailed to the CoC last week. I forwarded it to the current ESG recipients. However, the CoC does consider new applicants. If your agency is interested, please see the links below to see the instructions. Please keep in mind that this funding must go through the CoC. So even though it states that recipients must submit their applications by March 15, the CoC is required to also submit their funding recommendations. The threshold criteria set by the CoC include that your program must have been in operation for two years and you must have two consecutive years of audits performed by a CPA. When reviewing the instructions below, please keep in mind that this funding requires strict adherence to Grant Accountability and Transparency Act (GATA). You may wish to go to the GATA website to see what that entails. The CoC will ask that if you are a new applicant that you prove that you can meet the GATA requirements. https://www.illinois.gov/sites/gata/Pages/default.aspx. Failure to meet GATA requirements could result in loss of funding for the entire CoC.

In order for the CoC to review and offer guidance to ESG applicant's we ask that you have your applications to the CoC by March 2. If you are a new applicant, please advise via email to Mary Muehlenfeld your intent to apply by Monday, February 19. This is a requirement due to the extra time needed to review a new applicant.

It is extremely important that I receive your applications by March 2 because I have to complete a CoC application based on the agency applications submitted. Once the applications are reviewed and funding recommendations are made by the Research and Evaluation Committee, we will advise applicants to submit their applications directly to DHS. Without the CoC's recommendation of funding, applications will not be approved for funding by DHS.

The FY 19 grant applications for all programs funded by the Emergency Solutions Grant (ESG) are due **March 15, 2018**. Please inform the Providers in your CoC. To be eligible for a contract, all grantees must complete the Pre-Qualification Process, Internal Controls Questionnaire, Programmatic Risk Assessment and Grant application. The Grant Application and Programmatic Risk Assessment are to be completed for every program/grant. See <u>Grant Application Information and Instructions</u> webpage for more detail.
