1. Provide a description that addresses the entire scope of the proposed project.

This renewal project is for 5 leased units with support staff, administration, and HMIS already in place to begin operations immediately. It will assist literally homeless households as defined by HUD's Categories 1 and 4. Eligible homeless individuals and families must have one member of the household with a disabling condition as defined in the HEARTH Act. Sub-populations include all "specific populations focus" listed in Question 2a of this application including LGBTQ populations. This project enters households in accordance with HUD's CH Prioritization Policy Notice CPD-16-11.

Our CoC uses a coordinated entry approach established between this project and partner sources. Eligible participants are quickly identified and moved into our PSH if there is a vacancy. The Coordinated Entry Policy provides for the VI-SPDAT to be conducted within 72 hours of shelter entry to ensure that prolonged shelter stays can be avoided. Case coordination follows the coordinated entry process, intake process, and continues through the household's stay in PSH.

Housing and supportive services will be provided with few to no programmatic prerequisites to permanent housing entry, low barrier admission policies, rapid and streamlined entry into housing, and a Housing First case management method.

Participants have full rights, responsibilities, and legal protections. They are informed of the Fair Housing Act. The leases are project based so the target population is not rejected due to lack of resources to lease directly from a landlord.

A voluntary, client centered, Individual Service Plan will be developed with the head of household to address their needs based on their VI-SPDAT assessment and disabling condition documentation. Completion of the service plan will be used to measure progress but participation in services will not be a condition of housing.

Participants will be linked to service providers in the community and mainstream benefits. SOAR trained case managers will assist participants with navigating the system. Illinois has a single application for benefits. Counseling will be offered to educate participants on managing monetary and non-monetary resources to improve their financial situation. Engagement in these services will

be encouraged but not required. Education, employment, and accessing benefits are the primary focus to improving income.

Projected outcomes are at least 80% of households remain in the PSH project or exit for other permanent housing; participants maintain or increase their income; participants access mainstream and community benefits; participants have access to affordable healthcare; and that school-aged children are enrolled and attending school. Data for participants will be entered into our HMIS system to track outcomes.

The goal is for homeless households to achieve independent living and to maintain housing through stability. To attain this the project will require CoC program support.
